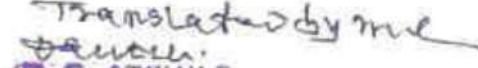

## RULES AND REGULATIONS OF THE ASSOCIATION

1. **The terms of reference (definitions) in Rules and Regulations.**  
The definitions of the terms are generally as below
  - a) **Executive Board :-** Means the board of members appointed or elected for the management of association
  - b) **Operational Area :-** means the topographical area within the limitation of which the association is going to work.
  - c) **Property of Association :** means all the belongings of the association in its possession may be all the investment, amount, movable and immovable property. This will include the amount accepted as donations for some specific purpose, any property.
  - d) **Member :** Any major Indian person man/woman who so ever would apply in the prescribed format and would be binding to the rules and regulations of the association. The said application must be accepted by the association and then the person becomes the member.
  - e) **Financial Year :** The period/ duration of 12 months extending from 1<sup>st</sup> April to 31<sup>st</sup> March of every year
2. **Operational Area :** Will be limited to Maharashtra state
3. **Account Year :** The duration of 12 months from 1<sup>st</sup> April to 31<sup>st</sup> March will be the account year.
4. **Members and membership Fees :** Any major person who agrees the rules, applies in the prescribed format and who pays the specified fees and if the said application is accepted by the executive board then the person becomes the member of the association.
5. **Types of Members :-**
  - a) **General Members :-** A person can be a general member by paying annual fees of Rs. 101/- within one month from the commencement of the financial year

b) **Life member** :- A person can be a life member of the association by paying donation of Rs. 201/- or more at the sametime; if he wishes the lifemembership and on consent of the executive board.

6. **Cancellation of Membership :**

1. If the members becomes punishable under any criminal case.
2. If he does any unfair act.
3. The membership of a person can be cancelled if his conduct is against the interests of association and such conduct is noticed/ made to notice by the executive board by someone, his membership will be cancelled with the rule of majority the executive board.

7. **Genral meeting and it's Rights :-**


1. General meeting will be conducted every year within the period of three months after the end of financial year.
2. All types of members can participate in this meeting.
3. There should not be any due of association towards the member. Such member will not be eligible for voting. Also if a person has obtained membership and has not completed period of one year, such member can attend general meeting but cannot caste vote.
4. To maintain control over the working of the executive board.
5. To grant sanction to the annual expenditure.
6. To prepare estimated budget for the next year and grant saction to it.
7. To elect executive board.
8. To present/ put the resolutions at the time of general meeting before the general meeting with permission of president and saction or reject the sanction of the same.
9. In the interest of the association if necessary the four members of executive board, the general meeting shall be held by the President of General Meeting within seven days.



8. **Notice of General Meeting and Corum :-**

The notice of general meeting will be served to the members either by Registered post or directly serving the notice. The notice should clearly mention in it the date, time, place and the subjects/resolutions in the meeting. Such notice will stick up in the office of association. The attendance of 2/3 general members is must to complete the corum. Such necessary corum for the general meeting is mentioned in the notice. Despite this due to incomplete corum the general meeting will not be cancelled but will be adjourned for half an hour and again it will be resumed. This will not require the condition of corum to be fulfilled.

9. **Special General Meeting and it's Functions : -**  
Special General meeting will be called if the president and executive board feels it necessary. The President shall call such meeting within one month after presenting the demand by 1/3 members in written to the general meeting. He shall call it with the help of secretary. The notice of such special meeting shall be served to the members along with the subjects 10 days prior to the date of meeting by registered post or directly to the member. Such special general meeting will not consider the subjects not included /mentioned along with the notice.
10. **Executive Borad, Officials and it's structure : -**  
The executive board of association will comprise of minimum 7 and maximum 21 members. The elected members of executive board will thereafter effect the officials as below i) President ii) Vice President iii) Secretary iv) Joint Secretary v) Treasurer vi) Member.
11. **Duration of Executive Board/Process of Election : -**  
a. The term/period of executive board will be of 5 years.  
b. The election of the executive board will be held at each 5 years interval in the general meeting.  
c. i) The member will not be eligible for election there is some due amount towards him to be paid to the association  
ii) The election officer shall be appointed seven days prior to the date of election.  
iii) The election will be held as per open voting system in the general meeting.  
iv) The person after completing the period of atleast one year as a member of general meeting can have the right to caste vote.  
v) The notice of election will be issued 7 days prior to the date of election through office.

12. **Executive Board Officials and their Functions : -**

a) **President :-**

To conduct working of association, issue proper orders in the interest of association, to maintain control on functioning of association and it's branches, conduct gneral meeting. The president will call such meeting if the secretary fails to do.


b) **Vice President :-**

He shall help the president in his work or will act/ work as president in the absence of president.

c) **Secretary :-**

- i) To call executive board meeting.  
ii) To do communication of association.  
iii) To solve the complaints

- iv) To look after legal proceedings in the court if necessary and related to the association.
- v) To keep watch on working of association.
- vi) To check daily accounts and sign them.
- vii) To supervise working of peon, consider and guide on their difficulties/problems and help them according to the necessity.
- viii) To implement/ execute the sanctioned resolutions as per sanction.

**d) Joint Secretary :-**

To assist/help secretary in his work or work as secretary in the absence of secretary with his prior permission.

**e) Treasurer :-**

To maintain control over the financial transactions of the association, maintain accounts by own or make other to maintain, put the completed accounts before secretary, to prepare annual account statements on the basis of books of accounts/registers. To operate make compliance of the curies/faults after carrying out the audit by auditor.

**f) Member :-**

To assist/ help in all works and participate in the meeting and voting.

**13. Executive Board Meeting and Meeting on Demand :-**

Executive Board Meeting should be called at an interval of atleast three months. An urgent executive board meeting shall be called if 1/3 of the e.b. members make demand in written for such meeting and it shall be called by the President within 3 days.


**14. Notice of Executive Board Meeting and Corum :-**

The notice of E.B.meeting shall be served 3 days pror to the meeting by registered post or directly to the member. Such meeting shall require 2/3 attendance of member to complete the corum. If meeting is adjourned for want of necessary corum, the meeting half an hour and such meeting shall not require corum.

**15. Rules of election of Executive Board :-**

1. The member having any kind of due towards him to be paid to the association shall not be eligible to content election of executive board.
2. The election officer should be appointed 7 days before the election.
3. The member must complete paeriod of atleast one year being member of the association and then only he/she can have the right to content/participate in the election.
4. The election will be according to open voting system.

16. **Filling up of the vacant post of Executive Board Members :-**

The officials of the executive board shall present their resignation to the President. The resignation should be sanctioned by the executive board with majority. The official will retain the designation till the sanction of the resignation. The vacancy of any of the board member created due to resignation or death shall be filled up with the new member by the cosent of the executive board.

17. **Executive Board it's Right and Duties :-**

1. The executive board meeting shall be called at an interval of atleast three months.
2. The president shall call an urgent E.B. meeting within 3 days if demanded by the five members in written.
3. To maintain control over the working of association and branches under it.
4. To appoint peons for association, keep watch on their work, also to dismiss them so that the association could work properly.
5. The prepare minor rules for the proper functioning of the association.
6. To execute the resolutions passed by general meeting.
7. Th prepared list of executive board annually and submit it to the office of Asst. Charity Commissioner of societies along with the copy of resolution. The change in the property or executive board of the association should be informed to the divisional office by an application.
8. To keep the list of members and the relevant details filled in Annexure II should be sent every year to the Registrar office.
9. To maintain the accounts of deposit and expenditure and do audit and the same audit should be presented before the general meeting
10. To appoint/form sub committees and delegate special powers to same members for some work.
11. The executive board requires 2/3 members to complete the corum. If the executive board meeting will be adjourned for the want of necessary corum, the meeting will be resumed at the same place after half and hour. Such meeting will not require the condition of corum.

18. **Grant, Property of association and it's utilization :-**

The grant includes membership fees, donation and govt. grant and the balance amount with the association after deducting programmes expenditure from the total grant will be utilized on the objectives of the association

19. **Provision for objective wise budget :-**

The sme expenditure ( budget) will be made on all the objectives.

20. **Provision regarding Loans or Deposits :-**  
The deposits or loans will be accepted as per the provision made, U/S 36A (3) of the act and with prior permission of Hon Joint Charity Commissioner, Aurangabad.
21. **Provision regarding Disposal of Immovable property :-**  
Disposal or sale of immovable property of the association will be made with the prior permission of Hon Joint Charity Commissioner, Aurangabad.
22. **Bank Accounts :-**  
The bank account in the name of association will be opened in the govt. recognized bank as per Bombay Trust Act. The withdrawal of the amount/cash will be done by President/Secretary/Treasurer by the joint signatures of the two out of 3 said officials .
23. **Methods of Maintaining list of Members :-**  
The list of members will be maintained as per Index no.6 in the prescribed format according to the provisions of societies Registration Act, 1860 made U/S 15. Also the index no. 1 and 2 formats shall be maintained ( The formats of Index 1,2,6 are enclosed alongwith the signatures of the applicants)
24. **The Provision regarding making changes in Rules and Regulations: -**  
The necessary changes i.e. addition of new or deletion of previous rules and regulation canbe made with 3/5 majority sanction in the general meeting.
25. **The Provision regarding making change in name of association or it's objectives :-**  
The procedure as per the provisions of the 1860 act made U/S 12 or 12A will be followed if the change in name of the association or it's objectives or merger of two association is to be made.
26. **Winding up :-**  
If teh association is to be wind up i.e. it's working is to be stopped permanently the resolution so should be passed with 3/5 majority. All the financial transactions (deposit and expenditure) should be completed. The balance property with the association can be donated to the other association. The procedure prescribed U/S 13 and 14 of the socities Regitration Act 1860 should be followed for the winding up of the association.
